## STUDENT BURSARIES

St Ives Choral Society will set aside up to £1000 per annum to enable the Society to award bursaries to young people under the age of 18 who sing on a regular basis as Choral Society Junior Members. This scheme will be administered according to the following rules:

- 1. Junior Choral Society members are able to join the Society without paying a subscription
- 2. Bursaries will be awarded up to a maximum of £250
- 3. Any Junior Member who has been with the Society for at least one term and has an attendance record of at least 80% (this level may be reduced to take account of exceptional circumstances e.g. illness, exams) is eligible to apply for a bursary
- 4. Bursaries will be awarded to assist the student with acquiring study materials, attendance at e.g. a Summer School or special extra lessons
- 5. Bursaries will be awarded to support any subject but preference will be given to those involving music
- 6. To apply for a bursary the attached Expression of Interest Form should be completed and returned to the address at the bottom of the form. Forms can be e-mailed but must be followed by a signed copy.
- 7. Once we receive an application we may wish to speak with or meet the applicant to discuss details before considering awarding the bursary
- 8. More than one application may be made but within a 3 year period it will only be possible to be awarded one bursary
- 9. Payment will be made in one of the following ways:
  - on production of receipts for the relevant purchases, courses etc.
  - by production of invoices. In this case payments will be made directly to the name/organisation on the invoice
